RE: Sex Offender Notification

BOE Policy #5450.1, Notification of Sex Offenders, requires me to notify all staff when the Broome County Sheriff's Department notifies the district that a Level 3 offender has moved into the Chenango Forks area. Please see attached.

Mr. Ingraham currently resides at 330 Pigeon Hill Rd., Chenango Forks, NY 13746 and is a Level 3 sex offender. Sex offender levels are assigned based on the risk of repeating the offense, Level 1 Low; Level 2 Moderate; Level 3 High Risk. As a Level 3 offender Mr. Ingraham "is prohibited from knowingly entering upon school grounds or other facilities where children are cared for, while one or more persons under the age of 18 are cared for. The exception to the above is when the Level 3 sex offender is a student or has a family member enrolled in the school. In this case, the Level 3 sex offender can enter the school grounds for limited purposes as authorized by the parole officer and the superintendent." Mr. Ingraham has made no contact with the district concerning this matter and is **not** to be allowed on the property of Chenango Forks Central Schools.

As this is a Level 3 notification, a letter will be posted to our webpage.

The security practices at each of our buildings and on our buses should protect our students from Mr. Ingraham and individuals like him. Your vigilance in following our security procedures will insure that sex offenders like Mr. Ingraham cannot gain access to our youngsters.
